**Methods of Distribution:** Monthly *Business Calls* issues shall be delivered by e-mail in a PDF format to all subscribers on or before the [first day of the month proceeding] for licensed use. Monthly issues may be used in the following manner:

- (1) Printed and mailed as a stand-alone document or sent together with other regular mailings such as monthly billings or statements.
- (2) Sent as an e-mail attachment to current and/or prospective clients.
- (3) Prior issues may be included as supplemental documents for use in targeted marketing proposals.

*Newsletters may NOT be used as part of any website, linked to any website or otherwise publicly accessible via Internet-based applications.*

**Modifications, Customization and Other Uses of Content:** All regular content shall be delivered on an as-is basis. Newsletter content is copyrighted and may not be altered or modified by the subscriber, or used in any other publication or for any other business purpose at any time without the expressed written permission of Business Calls, Inc. A regular monthly "Presidents letter" feature of at least 250 words but not to exceed 280 words may be incorporated into each monthly newsletter at an additional charge. Such letters must be received 5 business days in advance of the normal distribution date to allow sufficient time for customized production.
